Title: Christina Gabbitas visits to 10x NEL schools

Executive Summary:

The Force have identified localised need for early intervention in relation to violent offences and, building upon previous investment from the Humberside Early Intervention Programme (HEIP), it is proposed that Christina Gabbitas (with an officer) attend at set locations/schools across North East Lincolnshire to deliver a presentation and activities around the OPCC commissioned No More Knives comic and animation with input focused to knife crime, including elements also of grooming and CCE.

Decision: That visits to 10 targeted schools (across 5 days) in North East Lincolnshire be approved, at a total cost of £2990, to provide an early intervention input in areas that have seen, and that continue to have, a high demand in relation to violent offences.

The cost covers attendance and facilitation of sessions by Christina Gabbitas (accompanied by a PC/PCSO), a copy of the No More Knives comic for each student participating and signposting also to the wider Not In Our Community resource available.

Title: Christina Gabbitas visits to 10x NEL schools

1. Executive Summary

- 1.1. An opportunity has been identified to engage with young people in North East Lincolnshire and deliver activities at schools in relation to knife crime.
- 1.2. This input will target schools in areas of reported concerns and vulnerability and provide targeted early intervention across locations which currently have a high demand in relation to violent offences.
- 1.3. Targeting specific schools across North East Lincolnshire, it is proposed that Christina Gabbitas (with an officer) attend at set locations/schools to deliver a presentation around the OPCC commissioned No More Knives comic and animation with input focused to knife crime linking also to vulnerabilities around grooming and CCE.
- 1.4. The targeted approach will see locations identified (determined by the Force) by reviewing demand, information/intelligence and liaison with schools. The aim is for an early intervention input for areas that have seen and that currently have high demand in relation to violent offences.

2. Recommendation(s)

2.1 It is recommended that the OPCC support the proposal for Christina Gabbitas to facilitate workshops at 10 schools (2 per day, 5 days total) across North East Lincolnshire, based upon targeted need, and including signposting to the wider Not In Our Community resource available.

3. Background

3.1 In 2018 the OPCC secured funding from the Home Office for the Humberside Early Intervention Programme (HEIP). A key piece of work from that funding was the No More Knives book, written by Christina Gabbitas at Poems and Pictures Ltd, to help educate children aged 10-16 on the dangers of getting involved with county lines and carrying knives.

- 3.2 In October 2020 with the support of the OPCC (Decision Record 13/2020 refers), the book was turned into an animation.
- 3.3 Now in 2021, working alongside Humberside police who have highlighted an early intervention need in relation to violence using weapons in localised areas, this proposal sees this OPCC commissioned resource utilised to directly feed in and support the Force's work to respond to these demands.
- 3.4 Christina Gabbitas will present sessions as a guest speaker. She'll be accompanied by a PC/PCSO at all sessions to deliver a 'stronger together' message. Sessions will be aimed to predominantly year 6 students.
- 3.5 A copy of the No More Knives comic will be provided to all students taking part in the workshop along with information on NIOC Interact that includes a vear 6 pathway featuring the No More Knives animation.
- 3.6 This proposal is evidence based in terms of OCG activities and builds upon the former successful delivery of this project elsewhere in the force.

4. Options

- 1) Do nothing The Force have identified a need for early intervention for localised areas in relation to violent offences.
- 2) Visit fewer schools/scale back resources provided the Force will identify 10 schools based upon demand, information/intelligence and liaising with schools. Input will target schools in areas of reported concerns. The resources provided will generate conversations amongst peers and will be taken home for awareness raising across the family setting.
- 3) Fully fund visits to 10 schools across 5 days the need is targeted and intelled. It enables early intervention activities to continue in areas of demand whilst the OPCC and Force continue work to develop a Safer Schools offer.
