1. Executive Summary

The project will support the installation of new solar lighting to South Park playing area.

2. Recommendation(s)

That the PCC fund the installation of 9 solar lights at a cost of £13,607.91

3. Background

There have been ongoing safety concerns from the local community around use of the path leading to South Park playing area and the park itself in that it is extremely dark and therefore the CCTV in the area would have limited use.

The area is known to be an area that can often be targeted for Anti-Social Behaviour and Vandalism.

Additional lighting would improve people's perceptions of safety and enhance the opportunity for evidence collation should issues arise and CCTV capture any incidents.

4. Options

- Do Nothing do not support and encourage local councillors to seek other revenue streams. This would cause delays and mean likelihood of further ASB during darker nights over this winter period.
- 2) Fund contribution The monies sought are substantive enough to make them difficult to source and would further delay the installation.
- 3) Fund 100% The monies requested can be covered in full from the underspend identified in this years revenue budget. This will have a positive impact and immediate on the community.

5. Financial Implications

The project requires £13,607.91 of revenue monies to be paid in the 2021/22 financial year.

6. Legal Implications

It has been made clear that this is one off money and any maintenance is the responsibility of the grant applicant.

7. Driver for Change/Contribution to Delivery of the Police and Crime Plan

The investment will make a contribution to the Safer Communities strand of the Police and Crime Plan namely the improvement of safety of public spaces.

This investment will support the more equitable use of the park space by all members of the community which due to the current safety perceptions is difficult for those to access who think it is unsafe due to it being dark.
