1. Executive Summary

The Police and Crime Commissioner agreed new 3-year funding arrangements in 2022 for the Community Safety partnerships (CSPs). A decision record (452022) is in place for the agreement.

Within the agreement is an allocation of £297,452 per annum to be used as a project pot fund that CSPs can apply to.

CSPs submit funding applications to the Office of the Police and Crime Commissioner which are appraised with funding provided to the CSPs that are successful.

This decision record confirms the funding allocated during the first round of funding arrangements during the 2023/2024 financial year.

It should be noted that this decision record is for approval of CSP project pot applications as part of the previously agreed funding arrangements and is not seeking additional funding.

2. Recommendation(s)

Following consultation and appraisal, approve the round one applications totalling £130,966. The following projects from round one to be approved: -

3. Background

Community Safety Partnerships are statutory partnerships established by the Crime and Disorder Act 1998 to co-ordinate action on crime and disorder. Local authorities, police, fire and rescue authorities, health and probation services are statutory members. There are four CSPs in the Humberside, one for each local authority area.

The Police and Crime Commissioner has committed to 3-year funding arrangements for the CSPs that includes an annual project pot of £297,452. CSPs can bid into the project pot for funding, to deliver a strategic multi-agency response to issues in their areas aligned with the Police and Crime Plan.

To assist CSPs it has been agreed from the 01 April 2023 that funding applications will be in two rounds. The recommendations highlight the projects that should be approved from the first round.

4. Options

1) Decline the CSP project application funding applications

Whilst appraisals of projects are carried out with some rejected, the ones selected above are appropriate and meet the guidance of the projects fund. Declining the applications would affect the delivery of the submitted projects.

2) Approve the CSP project pot applications (recommended)

Consultation is carried out with staff within the Office of the Police and Crime Commissioner to ensure that the applications are not duplications of work that is already being carried out.

In addition, an appraisal of the applications is carried out to ensure that the project aligns with the outcomes of the Police and Crime Plan.

5. Financial Implications

The Chief financial Officer has confirmed that the budget noted above is available and is part of 3 years funding arrangements.

6. Legal Implications

Funding for the projects will be confirmed via an offer letter and grant agreement ensuring accountability. The agreement has been checked previously by the Head of Legal Services.

7. Driver for Change/Contribution to Delivery of the Police and Crime Plan

The Police and Crime Plan has effective organisations as one of its three aims, with better partnership working as a key outcome. It includes providing restructured funding to CSPs as an explicit commitment.

8. Equalities Implications (Have due regard to the Public Section Equality Duty)

No equalities implications have been identified for the OPCC. The funding will be provided to Local Authorities as nominated leads on behalf of the CSPs, both they and other statutory partners are subject to the Public Sector Equality Duty. CSPs are required to consider equality implications.

Consultation on the project pot applications is carried out relevant OPCC staff including the Chief Executive and Director of Policy and partnerships.
