Thank you for your Freedom of Information request submitted on 4 April 2014.

I confirm that this information is held by the Office of the Police and Crime Commissioner for Humberside. Please find below our response.

1. The total cost of the Police and Crime Commissioner's office for the financial years 2012-13 and 2013-14.

During 2012/13 the Police Authority was in existence from 1 April 2012 until 21 November 2012 when the Office of the Police and Crime Commissioner came into existence. The total cost of the Police Authority/Office of the Police and Crime Commissioner in 2012/13 was \pounds 1.434m.

The provisional total cost of the Office of the Police and Crime Commissioner in 2013/14 is £1.221m.

2. The total cost of the Police Authority body replaced by the Police and Crime Commissioner in the financial years 2010-11 and 2011-12.

The total cost of the Police Authority was in 2010/11 was \pounds 1.405m and in 2011/12 was \pounds 1.518m.

3. The total remuneration bill for the financial years 2012-13 and 2013-14 (remuneration should be taken to mean pay, pension contributions, bonuses and any other benefits in kind).

2012/13 £706,369 - this includes the part year effect of the cost of the PCC and Deputy but EXCLUDES the cost of Police Authority Members' Allowances which for the part year was £111,903. 2013/14 £825,630 - this includes the full year effect of the costs of the PCC and Deputy.

4. The total remuneration bill for the Police Authority body replaced by the Police and Crime Commissioner in the financial years 2010-11 and 2011-12 (remuneration should be taken to mean pay, pension contributions, bonuses and any other benefits in kind).

2010/11 £680,219 (excluding Members' Allowances of £190,499) 2011/12 £683,009 (excluding Members' Allowances of £183,343)

5. A full list of job titles at the Police and Crime Commissioner's office as at 04/04/2014.

The Office of the Police and Crime Commissioner employs 9 members of staff, including the Deputy Commissioner (2 of whom are part time). The structure, including job titles, is available on our website at <u>http://www.humberside-</u>

Following the approval by the Home Secretary of the Second Stage Staff Transfer, a Corporate Support Team has been created. The Corporate Support Team was established to avoid any duplication of work that occurred as a result of the Commissioner and the Force having staff carrying out similar roles. The team, which both the Chief Constable and the Commissioner have access to, is jointly funded.
