Misconduct Hearings are called by Humberside Police and the Office of the Police and Crime Commissioner for Humberside is requested by the Force to appoint an Independent Member. For the period 08.11.16-08.11.17 we have done this on 3 occasions (nb one Hearing was adjourned and therefore took place over 2 periods as detailed above), however, this will not provide a complete picture of all Misconduct Hearings held during this period as other Hearings, such as Special Case Hearings where an Independent Member is not required, may have been called by Humberside Police.
