Dear, thank you for your Freedom of Information request and for your subsequent clarification.

Our records have been checked and our response is as follows.

o All costs associated with the Police and Crime Commissioners expenses. o All costs associated with the Police and Crime Commissioners spending on Travel and meals.

o All costs associated with the employment of Political Advisers.

As indicated in our earlier response, the current Police and Crime Commissioner does not have any political advisers and has not appointed a Deputy Police and Crime Commissioner.

o All financial detail of spending reserves.

As you have not provided any further clarification we assume that this document has answered that part of your request. If it does not then please submit a further request.

o All information, including spending and detail of training days for PCC staff.

As indicated this information is not currently recorded centrally. Further to your clarification indicating that you were seeking details of "away days and CPD events", we tried to search on those items but this proved to be difficult and extremely time consuming. As you indicated that you were interested in spending in this area we therefore concentrated on looking at those training events that had been coded to "conference and seminar fees" within our budget and whilst this may not be a complete record we are able to provide the following information:
