Thank you for your email of 26th August, 2020 asking for information on a loan from Bridgend County Borough Council.

I can confirm that the Office of the Police and Crime Commissioner (OPCC) for Humberside does not hold any records relating to a loan from Bridgend County Borough Council.

In response to your more general questions, short term borrowing funds are accessed via approved Brokers utilising the Local Authority Lending/Borrowing market. It is standard practice for all Local Authorities, Police and Fire Services to borrow from and lend to each other for fixed periods of time for the purposes of short term cash flow management. Any loans are used for short term cash flow management.

Details of the Humberside OPCC's investments and borrowing are published on our website in our annual accounts: https://www.humberside-pcc.gov.uk/Transparency/What-We-Spend-and-How-We-Spend-It.aspx.

We are not able provide a tabular breakdown of lending and borrowing, due to the time it would take being greater than that allowed under section 12 of the Freedom of Information Act. If you are able to refine your request to clarify the dates, borrowers or lenders your request covers, then we will consider the request in light of that information.

If you think that we have not supplied information in accordance with our Publication Scheme or under general rights of access then you have the right to ask for an internal review. Any request for an internal review should be made within 40 days and addressed to:
