## Freedom of Information Act 2000 (FOIA) – Request for Information Our ref: FOI941

I refer to your recent Freedom of Information request submitted to the Office of the Police and Crime Commissioner for Humberside on 8 December 2021, as follows:

- 1) Excluding the PCC, what is the total number of staff (including the CEO) employed to work in the OPCC as of 6th December 2021?
- 2) How many of those staff attended the Team event in The Yorkshire Dales at any time between 09.00hrs Sunday 5th December and 19.00 hrs Tuesday 7th December 2021?
- 3) How many of those staff stayed overnight on Sunday 5th December 2021?
- 4) How many of those staff stayed overnight on Monday 6th December 2021?
- 5) How much did the accommodation cost the OPCC?
- 6) What is the total number of paid hours incurred for all of those staff attending the event, in whole or in part, including travel from The Lawns, Cottingham to the accommodation and any trips to and from the accommodation during the stay? This should include travel for any staff who did not stay overnight.
- 7) Where else did staff attend other than the accommodation during this whole event and what were the incurred costs for the OPCC?
- 8) What is the total cost to the OPCC for this event, including accommodation, mileage, salaries, food, drink and refreshments, admission fees and entertainment?
- 8). Did the PCC Jonathan Evison attend this event at an time? If so what salaried hours and mileage costs were incurred?
- 9) Did any external parties attend, including consultants? If so, what cost for fees and expenses were incurred for the OPCC?
- 10) Given the OPCC is publicly funded including council tax precept paid by Humberside residents, why was a venue outside Humberside selected?

- 6. Paid hours were from 9am till 5pm Monday 6th December. Those that stayed overnight Monday 6th December used two hours of paid time on Tuesday 7th December.

- 8. £1068.46 total costs were incurred. No additional salary costs or overtime payments were
- 8. The PCC attended Sunday and Monday. Working hours were 9am till 5pm Monday 6th December. No mileage claimed.
- 9. Yes. Cost £270 inclusive of VAT.
- 10. No suitable accommodation/venue could be identified in the Humberside area for the budget available.
