Dear , thank you for your Freedom of Information request in which you sought the following information -

- 1. All contracts awarded through the commissioning of sexual violence/abuse services or sexual violence/abuse<sup>[1]</sup> related services in 2012-13, 2013-14 and 2014-15. Please include the following details:
  - 1.1. Names of organisations awarded contracts
  - 1.2. Financial amounts awarded
  - 1.3. The duration of the contracts (including breakdown of amount awarded per year)

In relation to the above, please specify the category of the contracted services, i.e.:

- (i) advocacy, including independent sexual violence (ISVA) advice services
- (ii) face to face services: counselling, emotional support, group support
- (iii) forensic sexual assault services, including Sexual Assault Referral Centres (SARCs).
- 2. Plans, strategies or other public documents that relate to spending and investment in sexual violence/abuse services or sexual violence/abuse related services.

We have not 'commissioned' any sexual violence/abuse services (or related services) in the period covered by your request. We have, however for 2013/14 and 2014/15, made financial contributions and grant funded a number of services in the area. The Victims' Fund was not received by Police and Crime Commissioners until 2013/14 and so any request for information in 2012/13 should be directed to Humberside Police.

Groups that we have supported include Grimsby and Scunthorpe Rape Crisis (It's My Right), Hull Rape Crisis, ISVA posts and specialist Young People's ISVA posts, Hull and East Riding Survivors Trust, East Riding Domestic Violence Trust, Care Monkeys, Safeguarding Children and Crimestoppers. The range of services covered by these organisations include advocacy, counselling, emotional, group and peer-topeer support, a CSE publicity campaign and signposting to other specialist services.
