### 1. Executive Summary

The vital role of the Yorkshire and the Humber (YATH) Rehabilitation Analyst is hosted by the Humberside OPCC on behalf of the Yorkshire and the Humber Rehabilitation Partnership, a partnership of PCCs, HM Prison and Probation Service.

The role is two days a week and is responsible for development, implementation and reporting on a range of analytical products.

Four partner areas have agreed to contribute to the post from the 01 April 2023 to the 31 March 2025 and there will be a signed Service Level Agreement in place.

Contributions from each of the four partners are as follows: -

**£5200** for 23/24 to be invoiced and paid for by March 31, 2024 (Total £20,800) **£5500** for 24/25 to be invoiced and paid for by March 31, 2025 (Total £22,000)

#### 2. Recommendations

The four partner areas (listed below) contribute to the continuation of the Yorkshire and the Humber (YATH) Rehab Analyst.

- Humberside Police and Crime Commissioner
- North Yorkshire Police, Fire and Crime Commissioner
- South Yorkshire Police and Crime Commissioner
- West Yorkshire Combined Authority

Funding of the post should continue for a 24 month period from the 01 April 2023 to 31 March 2025.

### 3. Background

The post was initially established in 2020 as part of the recruitment of the information analyst. The role includes: -

- Providing informed briefings to advise the YATH RP of progress against analysis of national, regional, and local trends by using data and information from a diverse range of sources.
- Provide clear and reasoned advice to the YATH RRP on the outcomes.

- achieved by the HMPPS Reducing Reoffending Plan.
- Produce reports to the YATH RP and wider stakeholders
- Develop effective working relationships with partners
- Function as the principal analyst for the YATH RP, by creating bespoke
  information products by researching and identifying criminal justice and other
  open-source data sources; in addition to process mapping key transactional
  areas.

A summary of work will be produced at the end of each calendar year and shared with contributing partners.

### 4. Options

1) <u>Decline the request for a jointly funded YATH rehabilitation analyst</u>
The impact of the request being declined would mean that the role would cease to exist, impacting on the partnership data and analysis provided to the Police and Crime Commissioners. It would not be feasible for this role to be absorbed within current roles in the office or within the partner organisations listed (section 2).

2) Approve the request to jointly fund the YATH rehabilitation analyst (recommended)

Approval would ensure that the funding is in place for the post. A signed Service Level Agreement will put in place with the partner organisations mentioned earlier in this report as identified in the recommendations (section 2).
