1. Executive Summary

- 1.1 Following an earlier submissions paper regarding mainstreaming the cost of IDVAs and MARAC Coordinators across the PCC, Directors of Public Health and Clinical Commissioning Groups (see appendix 1 for ease of reference) the Commissioner deferred the decision pending further information and clarity. It is proposed that this further information and clarity is provided by CAADA and their proposal is attached at appendix 2.
- 1.2 The proposed review of domestic abuse services will include:
 - An analysis of all current funding for domestic abuse services across
 the different parts of the Force area/local authorities, an analysis of the
 number of people supported, the interventions provided and a
 comparison of data between areas.
 - Advice on whether the existing provision for domestic abuse addresses the risks and needs of, medium and standard risk victims.
 - An estimate of capacity required for a risk led response to adult victims.
 - High level recommendations relating to the governance and oversight of this funding.
- 1.3 This review will build on the work already carried out by the Commissioner's Office and represents an opportunity to work pan Humber and bring a consistent and high quality response to victims and their children.
- 1.4 In addition, as part of the decision to support an additional ISVA on the North Bank, the Commissioner also requested a report from each local authority on the level of support to child victims of sexual abuse and the level of need. The response from each local authority is attached as appendix 3.

2. Recommendation(s)

2.1 It is recommended that the Commissioner approves the review of domestic abuse services as outlined at 4.2 (option 2) below and at appendix 2 and identifies the next steps following receipt of the responses from the local authorities.

3. Background

All the essential background is included in the report attached as appendix 1.

4. Options

Option 1

4.1 That the OPCC conducts a more extensive review of domestic abuse services to provide the further information and clarity sought.

Option 2

4.2 That the PCC engages a consultancy firm with an expert understanding of domestic abuse services and the various funding streams attached to IDVAs and MARAC Coordinators.

5. Risks

5.1 The risk with option 1 is the amount of time that this will require from OPCC staff and divert resource away from other areas of importance such as Victim Services Commissioning and Restorative Justice Commissioning. This could be mitigated if a staff member is made available from another area within the Corporate Support Team (CST).

6. Financial Implications

6.1 There is only opportunity costs associated with option 1. The second option will cost £15,000 plus VAT. Funding can be provided from the grant funding for the local commissioning of victims support services.

7. Legal Implications

7.1 There are no legal implications associated with this report.

8.1 There are no known equalities implications associated with this report.

9. Consultation

9.1 The OPCC has consulted all four Community Safety Partnerships, Hull DAP and It's my Right about the review and all have indicated their support and cooperation for such a review and to act as key points of contact.
