Title: Additional Funding for Community Safety Partnerships 2017/18

## **Executive Summary:**

The approved Medium Term Resource Strategy (MTRS) which supported the Commissioner's recommended precept proposal endorsed by the Police and Crime Panel included details of the amounts that will be made available to support Community Safety Partnerships (CSPs) in 2017/18. In addition it set out the conditions associated with this funding, including the requirement to ring fence monies for the continuation of crime reduction fund grants.

This arrangement has been discussed with the four unitary authorities in the Humberside Force area who act as accountable bodies for the CSPs as well as with the local CSP managers and other stakeholders.

The MTRS identified the following allocations in relation to the commitments in 2017/18, including funding that has already been agreed linked with Drug Intervention Programmes (funding for Victims' Services is not included). The table below provides the details and also highlights the amounts to be ring fenced for crime reduction fund grants in each area:-

The MTRS identified that £1.5m from the reported projected underspend for 2016/17 should be used to increase the amount held in the Commissioner's Partnership Reserve.

Following further discussions with local authorities and the CSPs, it is now proposed that this amount should be made available to support their activities in the same proportion as the original allocation in the table above.

As this is funding from the Reserve it does not represent an ongoing commitment and will represent a one-off allocation. The CSPs have requested that there should be some flexibility over the timing of the support so that it can be spread over a number of financial years as opposed to being required to be spent specifically in 2017/18.

This report seeks approval to the allocation of the additional £1.5m to support CSP activities and for this to be met from the Partnership Reserve along with proposals for the CSPs to be requested to submit delivery plans indicating how and when it will be used.

## Decision:

- (a) That the proposals to allocate an additional amount of £1.5m to the four unitary authorities in the Humberside Police Force area to support the work of their respective CSPs be approved
- (b) That the individual allocations are as follows:-
