1. Executive Summary

As part of the long-term objectives of the Public Health Approach to Domestic Abuse (PHADA) Project to prevent violence in the home, we would like to extend the evaluation period of the current educational intervention pilot in the HU9 postcode area of Hull; evaluating the long-term effectiveness of a trauma-informed approach and seeking to identify a sustainable model.

2. Recommendation(s)

To approve the funding of £10,000 for additional evaluation and research purposes.

3. Background

4. Options

- Do nothing, do not provide the funding. This option is not recommended as we believe this provides an excellent opportunity for an increased understanding of the impact and sustainability of a trauma-informed approach within education.
- 2) Use an alternative method to fund this longitudinal study.
- 3) Fully fund the request. This option is supported and recommended as it will provide us additional research material and learning.

5. Financial Implications

Total spend will be £10,000, to be paid directly to the University of Hull research and evaluation team, costings are in line with previous similar spend.

6. Legal Implications

Ethical research methods associated with evaluation to be agreed and met by University of Hull. GDPR requirements to be agreed and signed off by OPCC Data Protection lead.

7. Driver for Change/Contribution to Delivery of the Police and Crime Plan

This research will help progress two key aims of OPCC activity:

- Engaged, Resilient and Inclusive Communities
- Safer Communities –to focus activities on interventions that significantly impact on local crime levels

8. Equalities Implications

The pilot geographical area has been selected using Operation Encompass data and additional supporting information to identify the highest prevalence of children affected by domestic abuse within the Humber area; Hull was one of three key area and HU9 has been specifically targeted due to significant social and economic deprivation indicators alongside high volume of reported Domestic Abuse.

9. Consultation

Key stakeholders views have been sought and used to inform this proposal, both schools have consented to potential further participation in a pilot study, subject to ethical approval.

10. Media information

This pilot study forms part of our wider partnership work in supporting children and young people, preventing serious violence and improving the evidence base for positive interventions with those affected by domestic abuse.

HU9 Trauma-Informed Education Pilot – Longitudinal Study

Background paper

Opportunity to pilot a trauma informed approach

- 1. We are currently running a trauma-informed education intervention pilot with two schools and two children's centres in the HU9 Marfleet area of Hull (background data provided in Decision Record 12/2022).
- 2. All education settings have now received trauma-informed training and ongoing therapeutic peer support from a training and therapy provider.
- 3. Evaluation of the pilot has been provided by a team from the University of Hull and is due to end in June/July 2023, with a report due in August 2023.
- 4. A funded longitudinal study would allow the team to re-visit the two key schools to evaluate the longer-term impact of the training and to better understand to what extent a trauma-informed relational approach has been embedded, taking into account attendance rates, isolations and exclusions and measurement of wellbeing of both staff and children and young people.
- 5. The additional study would take place after an appropriate length of time has passed, as decided by the evaluation team and will include an additional mini literature review to take into account any new findings in the time elapsed.
- 6. Staff and senior leadership from both the primary and secondary school will be invited to take part in a survey and focus groups/interviews to review their knowledge and experience of using a trauma-informed approach within their education setting. The survey will seek to understand any barriers to implementation, any observation of positive change and any recommendations to support sustainability.
