I refer to your recent Freedom of Information request submitted to the Office of the Police and Crime Commissioner for Humberside received on 5 August 2024 as follows: -

***This is a request for information in relation to the appointment of Leo Hammond as deputy police commissioner wef 12 August 2024.***

***It is stated that***

***The Job Title – Deputy Police and Crime Commissioner The Salary and Rewards – Band C £37,347 - £43,230 fixed term (election May 2028)***

- ***I wish to know if that stated pay band is per annum or is the total amount to be paid for the period to May 2028.***
- ***Related to this I wish to know what amount of time the individual is required/expected to contribute to the role each 12 month period.***
- ***I also wish to have any information as to how this role was advertised or was it simply an appointment made on the recommendation of the current Police and Crime Commissioner.***

In response to your request, I can advise that the following information is held by the Office of the Police and Crime Commissioner for Humberside: -

- The stated pay band is per annum.
- The role is contracted to work 37 hours per week.
- The appointment was made on the recommendation of the Police and Crime Commissioner.
