Notice is hereby given that between 20 July and 31 August 2021 (inclusive) any interested party will have the opportunity to inspect the accounts of the Police and Crime Commissioner for Humberside and the Police and Crime Commissioner's Group Accounts and the Chief Constable's Statement of Accounts for 2020/21 and all books, deeds, contracts, bills, vouchers and receipts and other documents relating to them.

The inspection can be undertaken by prior appointment between the hours of 9.00am and 4.00pm Monday to Friday at the Finance Section, Priory Road, Hull. If you wish to inspect the accounts please contact us and we will arrange for you to view them within our premises. Applications should be made initially to the Head of Finance and Business Services/Section 151 Officer to the Chief Constable of Humberside (tel: 01482 220308).

Copies of all or any part of the accounts or those other documents referred to above may be made, subject to payment of a copying charge.

Mazars' Director, Public Services, Mr. G. Barker, Mazars LLP, The Corner, Bank Chambers, 26 Mosley Street, Newcastle upon Tyne, NE1 1DF, is the local auditor. A local government elector for the area, or any representative of the elector, has the opportunity to question the auditor about the accounting records. An elector also has the right to make an objection to the auditor where there are concerns on matters in respect of which the auditor could make a public interest report or where the auditor could apply for a declaration that an item of account is contrary to law.

To be considered, an objection must be made in writing to Mazars LLP and a copy has to be sent to the Chief Executive or Chief Constable.

The rights to question and object must be exercised within the period of 30 working days referred to above.
